Acceptance of the Terms of Use

These terms of use are entered into by and between You and Zerion ("**Company**", "**we**" or "**us**"). The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, these "**Terms of Use**"), govern your access to and use of the Zerion website and Platform, including any content, functionality and services offered on or through www.zerion.io (the "**Website**").
